H.R. 2441 would direct the Department of Veterans Affairs (VA) to expand the Rural Access Network Growth Enhancement program to three additional medical facilities. Through that program, VA provides case management services to veterans residing in rural areas who have severe and persistent mental illnesses. The bill would require the department to establish the program at the new locations in 2022. The bill would authorize the appropriation of \$1.2 million each year from 2022 through 2024 for that purpose. CBO estimates that implementing the program expansion would cost \$3 million over the 2021-2026 period, assuming appropriation of the specified amount.

H.R. 2441 also would require the Government Accountability Office to conduct a study on whether VA has sufficient resources to meet the mental health care needs of rural veterans. Using information on similar reports, CBO estimates that satisfying the reporting requirement would cost \$1 million.

In total, CBO estimates that implementing H.R. 2441 would cost \$4 million over the 2021-2026 period; such spending would be subject to the availability of appropriated funds.

The costs of the legislation, detailed in Table 1, fall within budget function 700 (veterans' benefits and services).
