a. The estimated budgetary effects of subtitle N (fossil fuel resources) reflect significant interactions among individual sections within that subtitle and with title III, section 30114, and thus are shown as a single total.

Estimates for title VII reflect the enactment of H.R. 3684, the Infrastructure Investment and Jobs Act.

Budget authority reflects appropriations specifically provided in title VII or amounts estimated by CBO.

The costs of title VII fall within budget functions 300 (natural resources and environment), 450 (community and regional development), 550 (health), 800 (general government), and 950 (undistributed offsetting receipts).

The Budget Control Act of 2011 (BCA) requires the annual sequestration of nonexempt mandatory spending programs. The Office of Management and Budget determines which accounts are subject to reductions under the BCA. Some of the accounts affected by title VII are subject to sequestration; this estimate reflects the effects of sequestration on those accounts.

CBO estimates that sections 70709 (in subtitle G, public lands), 70801 (in subtitle H, drought response and preparedness), 71201 (in subtitle L, Arctic National Wildlife Refuge), and 71301 (in subtitle M, Outer Continental Shelf oil and gas leasing) would *increase* direct spending after 2031 and that subtitle N (fossil fuel resources), on net, would *decrease* direct spending after 2031. On balance, CBO cannot determine whether title VII would increase or decrease deficits because of the significant uncertainty surrounding receipts associated with federal mineral leasing and development activities after 2031.

Title VII contains no intergovernmental or private-sector mandates as defined in the Unfunded Mandates Reform Act.
